AUTOCASE TERMS OF USE AGREEMENT

Welcome to Autocase ("Autocase"), operated by Impact Infrastructure Inc., located at 230 Park Avenue, 3rd floor West, New York, NY 10169 ("Impact Infrastructure," "we," or "our").

By using the website located at autocase.com, as well as any subdomains thereof; the related mobile website; and the accompanying software-as-a-service (collectively, the "Service"), you agree to be bound by these Terms of Use (this "Terms of Use" or "Agreement"), whether or not you register as a member of the Service ("Member"). If you wish to become a Member and/or make use of the Service, please read this Agreement. If you object to anything in this Agreement or the Autocase Privacy Policy, do not use the Service. For the sake of clarity, the term Service as used herein does not apply to our Advisory Services, such services which are governed by a separate agreement. Autocase, the software, should be used as it's intended. As such, an Autocase project constitutes a singular building, with its surrounding site, with its own unique address, square footage, and program. Multiple buildings at a singular location, buildings or sites within a catchment area, or a set of similar buildings or sites should be analyzed as separate projects, and together using the Portfolios view.
